- (ii) To provide incentives for promotion of research and innovation

**[4] Nature of the Award**

An open award to all the Science and Technology disciplines/subject. The award is meant for faculty members/scientists of Uttarakhand state Universities only.

**[5] The Year of Institution of the Award:** 2015

**[6] The Year of Publication of the Research Article to be Recognized:**

1<sup>st</sup> July of the preceding year to the 30<sup>th</sup> June of the Year of the Award (e.g., July 01, 2021 to June 30, 2022)

**[7] Frequency:** Annual

**[8] Eligibility Criteria:**

All the faculty members/scientists/researchers who are engaged in some of the universities or colleges of Uttarakhand and have published some research article in SCI indexed Journal are eligible for applying for the best research article award. The research work must be original and well-focused on some important theme. The award is meant for individuals for their extraordinary, original and creative contributions in advancement in science, concept, new technology, innovation, prototype, software etc.

**[9] Assessment Committee:**

There shall be an assessment committee of 03 members including the Chairperson to evaluate the applications and make appropriate recommendation to the Hon’ble Governor, Uttarakhand. The Committee will be appointed by the Hon’ble Governor. The Committee may take assistance from subject experts, *if required*.

**[10] Assessment Methodology for the Award:**

(10.1) The article must be published in some SCI indexed journal during the preceding academic session, and the corresponding author of the article must be engaged in some of the universities of Uttarakhand.

(10.2) Every paper will be assessed on a 100-point scale as described in Table 1. On this scale, (i) the impact factor of the SCI indexed journal will constitute 45% component of the weightage of the article; (ii) the citations of the article upto 30<sup>th</sup> June of the year of the award will constitute 30% of the weightage of the article; and (iii) Remaining 25 % component of the weightage will be assessed by the committee in consultation with subject experts on the basis of (i) Scientific, technological, industrial and socio-economic relevance of the research published in the article, (ii) Significant knowledge generation in Science/Technology and patents obtained, *if any*, (iii) Conceptual clarity, novelty and originality of the research work.

(10.3) Contribution of impact factor (*to be determined as per Thomson Reuters list*) of the Journal will be determined using the method suggested by UGC in its Regulations, 2018. Maximum points, which an applicant or researcher may obtain for his research article, will be 45, even if the calculated points using Table 2 are higher.

(10.4) The citations of the article in the year of the award will constitute 30% of the weightage of the article. While assessing the research article, the applicant may obtain maximum 30 points using the Table 3.

**[10] Assessment Methodology for the Award:**

(10.1) The article must be published in some reputed and established journal (present in UGC CARE list) during the preceding academic session, and the corresponding author of the article must be engaged in some of the universities of Uttarakhand.

(10.2) Every paper will be assessed on a 100-point scale as described in Table 1. The assessment will be carried out by the assessment committee or the subject experts.

The Committee will be appointed by the Hon’ble Governor. The Committee may take assistance from subject experts, *if required*.

**[10] Assessment Methodology for the Award:**

(10.1) The article must be published in some reputed and established journal (present in UGC CARE list) or some other Journal and/or publishing source during the preceding academic session, and the corresponding author of the article must be engaged in some of the universities of Uttarakhand.

(10.2) Every paper will be assessed on a 100-point scale as described in Table 1. The assessment will be carried out by the assessment committee or the subject experts.
