Online Applications are invited from eligible Indian citizens and overseas citizens of India for the post of **Professors** in the Academic Pay Level -14 (Rs. 1,44,200.00 to 2,18,200.00) of 7<sup>th</sup> Central Pay Commission Pay Matrix, in various Departments of the University. The qualification shall be as per UGC (Minimum Qualification for Appointment of Teachers and others Academic Staff in the Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) Regulation 2018.

i) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-care listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2.

ii) A minimum of 10 years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor and/or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

B.

An outstanding professional having a Ph.D. degree in the relevant/ allied/ applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/ allied relevant discipline, supported by documentary evidence provided he/ she has ten years' experience.

The Research score for research papers would be augmented as follows:

Peer-Reviewed or UGC- care listed Journals (Impact factor to be determined as per Thomson Reuter's list):

i)	Paper in refereed journals without impact factor	-	5 Points
ii)	Paper with impact factor less than1	-	10 Points
iii)	Paper with impact factor between 1 and 2	-	15 Points
iv)	Paper with impact factor between 2 and 5	-	20 Points
v)	Paper with impact factor between 5 and 10	-	25 Points
vi)	Paper with impact factor > 10	_	30 Points

- (a) Two authors: 70% of total value of publication for each author.
- (b) More than two authors: 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors.

Joint Projects: Principal Investigator and Co-investigator would get 50% each.

#### Note:

- Paper presented if part of edited book or proceeding then it can be claimed only once.
- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co-supervisor. Supervisor and Co-supervisor, both shall get 7 marks each.
- \*For the purpose of calculating research score of the teacher the combined research score from the categories of 5 (b) Policy Document and 6 Invited lectures/Resource Person/Paper Presentation shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.

# II. Screening of candidates: Criteria and Process

- 1. The Screening Committee will draw a list of all the candidates indicating the research score scored by them in descending order i.e. starting from the candidate getting the highest marks towards the candidates getting the lower marks.
- 2. For appointment to the post of Professor in the University Departments, there is a requirement of a total research score of One Twenty (120) as per criteria given in Section I of this document.
- 3. The time taken by candidates to acquire M.Phil. and / or Ph.D. Degree shall not be considered as teaching/ research experience to be claimed for appointment to the teaching positions.
- 4. The period of active service spent on pursuing research degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment/promotion.
- 5. In case of any dispute with regard to screening of the applications, the decision of the Screening Committee shall be final.
- 6. The status of short-listing will be made available on the university website for applicant's information.

# III. Important Note

- 1. The entire onus of the content/authenticity of the information being uploaded in the form of application and its attachments shall exclusively rest with the applicant in terms of eligibility for recruitment and for subsequent selection through due process.
- 2. The University shall, in no way, be responsible for any error/omission/commission/suppression of relevant information by the applicant knowingly/unknowingly/overtly/covertly while filling up the application form and uploading the documents required therein.
- 3. In case the applicant gets screened/selected/appointed on the basis of the credentials furnished by him/her which are, on scrutiny, found to be incorrect/ inadmissible/ forged/fabricated/falsified, his/her candidature shall be liable to be cancelled at any stage of the recruitment/at any time during the tenure of the service and appropriate legal action under applicable law shall be initiated against the applicant.

#### **General Instructions for Applicants of Professors: -**

- 1. Applicants are required to apply online in the prescribed format with complete and correct information with desired attachments. The online link will be available live from 24-02-2023 (Friday) and will be closed on 25-03-2023 (Saturday, by 23:59:59 hrs.). The applicant will be solely responsible for the authenticity of the submitted information.
- 2. Applicants are required to register on SAMARTH recruitment portal through the link available on the University website <a href="www.doonuniversity.ac.in">www.doonuniversity.ac.in</a> or through Link: <a href="https://doonuniversityrec.samarth.edu.in">https://doonuniversityrec.samarth.edu.in</a> to fill the on-line application form. The details regarding qualifications, experience, screening guidelines and indicative proformas etc. are available on the University website <a href="www.doonuniversity.ac.in">www.doonuniversity.ac.in</a>, along with this notification. The applicants are required to read these details before filling up the form.
- 3. Applicants should possess the prescribed qualifications and experience as on the closing date of application, as prescribed by the University from time to time for the respective posts. The posts advertised carry UGC pay scales plus admissible allowances. The posts are being advertised keeping in view the broad areas of specialization in subjects. However, the Department concerned may have specific requirement of specialization.
- 4. Applicants who have been awarded Ph. D. from foreign Universities should enclose "Equivalence Certificate" issued by Association of Indian Universities, New Delhi, without which their candidature will not be considered and application will summarily be rejected.
- 5. The applications received shall be screened as per screening guidelines attached with this advertisement for short listing and recommending the applicants to be called for interview.
- 6. Mere fulfillment of the qualification or the eligibility criteria does not entitle an applicant to be necessarily considered or called for interview.
- 7. Publications 'under submission' or submitted to referees will not be considered towards calculation of marks for publication criteria. Further, all the items for which marks are claimed should be strictly in accordance with the screening guidelines attached with the advertisement.
- 8. - 9. The reservation for applicants from SC, ST, EWS, OBC (non-creamy layer), and Persons with Disability (PWD) categories will be applicable as per State Government norms.
- a. Applicants seeking reservation benefits available for SC/ ST/ OBC/ EWS/ PWD categories must upload the necessary documents justifying the claim of respective reservation as per norms. The certificate uploaded should be in the format prescribed by the Government and should be digitally verifiable.

- b. In case the applicant wants to claim benefits under the PWD category, the applicant's relevant disability should not be less than 40 per cent. Proof to this effect in the form of a valid Disability Certificate must be uploaded with the application.
- c. If the relevant certificates for respective reserved categories are not uploaded with the application, the application will be treated under General Category if found eligible.
- 10. Consequent upon adoption of self-certification provisions as required by the Govt. of India, the University shall process the applications entirely on the basis of information/ documents uploaded with the application. In case the information/ documents are found to be false/incorrect by way of omission or commission, the responsibility shall lie solely with the applicant and the applicant shall be liable for action as per law.
- 11. Applicants serving in Government/ Public Sector Undertakings (including Boards/ Autonomous Bodies) are required to submit 'No Objection Certificate' from the employer, at the time of interview, if not uploaded with the online application earlier. The NOC should also indicate the vigilance clearance from the parent department.
- 12. Candidates are required to mention the serial number of the journal as indicated by UGC Care list, impact factor (JCR) and author status related to all the publications. The proof of status of journal like peer reviewed /UGC Care listed/Scopus Index etc, impact factor, authorship claim etc. should be provided with valid document proofs, failing which points will not be given as per the claim, hence University will not be responsible for any mistake in score.
- 13. The candidates from Non-Government organizations are required to submit Form-16 for claiming their monthly emoluments in support of their claimed experience.
- 14. All necessary scanned documents being uploaded with on-line application form must be of high resolution, good quality, clearly readable and should be digitally verifiable, failing which, application form shall be summarily rejected and no correspondence shall be entertained by the University in this regard. Therefore, applicants are strictly advised to ensure uploading of documents accordingly.
- 15. All correspondence from the University including interview letter shall be sent only to the e-mail address provided by the applicant in the online application form.
