Minutes of the 33rd Meeting of the Executive Council

33rd Meeting of the Executive Council of Doon University was held on 29th August 2021 (Sunday) in the Vice Chancellor office. Prof. Surekha Dangwal, Vice Chancellor presided over the meeting. Following members were present in the meeting:

Dr. (Smt.) Suman Bansal and Dr. Naresh Mishra could not attend the meeting due to their prior engagements.

At the outset, Prof. Surekha Dangwal, Vice Chancellor & Chairperson extended a warm welcome to the members of the Executive Council. Thereafter the action taken report on the resolutions of 32nd meeting of the Executive Council was presented and the agenda items were taken up one by one for discussion.

Item 2021:33:02 Confirmation of the Minutes of the 32nd Meeting of the Executive Council held on 14th February 2020.

Since no comments and observations were received from Hon'ble members, the Executive Council confirmed the minutes of 32nd meeting of E.C.

Item 2021:33:03 Review of action taken on the resolutions of 32nd Meeting of the Executive Council.

Action taken was reviewed by the Executive Council.

Item 2021:33:04 To report joining of Prof. Surekha Dangwal as Vice Chancellor and Dr. Mangal Singh Mandrawal as Registrar of Doon University.

The Executive Council took note of the joining of Prof. Surekha Dangwal as Vice Chancellor and Dr. M.S. Mandrawal as Registrar of the University and welcomed them.

Item 2021:33:05 To approve the Minutes of the 19th and 20th meeting of the Finance Committee.

The Finance Controller, in the discussion, apprised the EC that in the Item No.: 2020:19:11 of the 19th meeting of the Finance Committee it was mistakenly mentioned that, "The Finance Committee considered the proposal for waiving of fees for students and resolved to waive all other fee."

Finance Controller added that it is policy matter hence university will follow the guide lines of the state government in this regard.

The EC approved corrected minutes of 19th meeting and minutes of 20th meeting of the Finance Committee as proposed.

Item 2021:33:06 To Report and approve appointment of new Faculty members and promotion of faculty members under Career Advancement Scheme (CAS).

The Executive Council considered and approved the recommendations of the Selection Committee for the direct appointment of Professor, Associate Professors and Assistant Professors, promotion under Career Advancement Scheme and their joining. The EC permitted to re-advertise the remaining vacant faculty positions.

The Chairperson presented the recommendations of the Selection Committee held on July 04, 2021 for the consideration and approval of the Executive Council. The Executive Council considered and approved the recommendations of the Selection Committee for the appointment of Associate Professor in the Department of English, School of Languages as follows:

Item 2021:33:09**To consider the Committee's report on the matter of appointment of Dr. Gajendra Singh, Associate Professor, School of Management.**

It was considered that the executive council in the 32nd meeting (held on 14th February 2020) had resolved that for all the three cases, viz, those of Dr. S. S. Suthar, Dr. Rajesh Kumar and Dr. Gajendra Singh where the respective committees have already submitted their reports, an expert on personnel matters may be requested to first examine all the three reports and other relevant documents, including replies of the officer concerned, if any and give his advice. Such a resolution was made in the interest of equity and a similar treatment. In this context, the name of Mr. P.C. Khare, Additional Secretary and representative of Secretary, Dept. of Finance was agreed upon. Mr. Khare was provided all the reports along with relevant documents but due to his retirement he could not complete the process. Then, the competent authority (i.e., Vice Chancellor) had nominated Dr. U. S. Rawat, Ex Vice Chancellor SDS Uttarakhand University and present V.C. SGRR University to examine all the three reports.

The Executive Council took a note of the report, submitted by Dr. U. S. Rawat in the sealed envelope and found that there is some ambiguity and unclarity in the report of Inquiry Committee in context of eligibility or ineligibility of Dr Gajendra Singh with regard to the eight years of experience.

The Executive Council deliberated at length over the issues highlighted in the complaints made against appointment of Dr. Gajendra Singh, his previous experience and his eligibility for the post of Associate Professor at Doon University. The EC also took note of the report of the Inquiry Committee constituted for examining the issues raised against appointment of Dr Gajendra Singh together with the order dated- 26th July 2019, passed by the Hon'ble Uttarakhand High Court in the writ petition no. 329 of 2020 (S/B) of Dr. Gajendra Singh.

After due deliberations, the Executive Council resolved to constitute a fresh three-member Committee, the members of which will be: (i) Prof D D Arora , Member EC (ii) Prof G S Batra, Member EC (iii) Dr. H.M. Aazad, Dy. Registrar, H.N.B. Garhwal University, Srinagar. This fresh committee will examine and inquire the whole facts in relation to the appointment, eligibility and delay in filing complaint against the appointment of Dr. Gajendra Singh in accordance with Advertisement, relevant rules & regulations, complainant's letter, reply of Dr. Gajendra Singh, additional reply of Dr. Gajendra Singh against the report, and all the documents available on record. This Inquiry Committee will record all facts and will submit its clear-cut findings over the referred matter for further necessary actions by the University.

Item 2021:33:10 To report the committee's report on the matter of Academic experience/ Ph. D. degree of Dr. Rajesh Kumar, Associate Professor, School of Media and Communication Studies in relation to complaints made by Mr. Shanti Prasad Bhatt.

It was considered that the Executive Council in the 32nd meeting (held on 14th February 2020) had resolved that for all the three cases. viz, those of Dr. S. S. Suthar, Dr. Rajesh Kumar and Dr. Gajendra Singh where the respective committees have already submitted their reports, an expert on personnel matters may be requested to first examine all the three reports and other relevant documents, including replies of the officer concerned, if any and give his advice. Such a resolution was made in the interest of equity and a similar treatment. In this context, the name of Mr. P.C. Khare, Additional Secretary and representative of Secretary, Dept. of Finance was agreed upon. Mr. Khare was provided all the reports along with relevant documents but due to his retirement he could not complete the process. Then, the competent authority (i had nominated Dr. U. S. Rawat, Ex Vice Chancellor SDS Uttarakhand University and present V.C. SGRR University to examine all the three reports.

The Executive Council took a note of the report submitted by Dr. U. S. Rawat in the sealed envelope. Executive Council also took the cognizance of the fact that the matter related to the appointment of Dr. Rajesh Kumar is under consideration before Hon'ble High Court of Nainital.

Item 2021:33:11 To consider the matter of Dr. S.S. Suthar, Associate Professor, SENR in resolution of the E.C. in its 32nd meeting.

Executive Council considered all the points, elaborated under the agenda document under item no. 2021:33:11 about the appointment of Dr. Surendra Singh Suthar at the post of Associate Professor in the School of Environment and Natural Resources (SENR) in year 2010. The recent representation of Dr. S.S. Suthar and the report (submitted by Dr. U. S. Rawat in sealed cover) were also taken into consideration. After a very careful perusal and comprehensive discussion on the all the facts and related documents, executive council resolves that:

- (i) In year 2010, UGC Regulations 2000 on minimum qualifications for appointment and Career Advancement of Lecturers, Readers and Professors in the Universities and Colleges were in force. These regulations came into the effect on 4th April 2000 in suppression of UGC Regulation No. F.1-11/87 (CPP-II) dated 19th September, 1991 and Notification No. F.3-1/94 (PS) dated 24th December, 1998. In these UGC Regulations 2000, UGC did not prescribe any rules for the counting of past services for direct recruitment and/or promotion under career advancement scheme. The advertisement (employment notice number 1/2010) dated 24th March 2010, was issued by the University in accordance with UGC Regulations 2000. During the period from 4th April 2000 to 29th June 2010, UGC did not issue any notification or clarification with regard to the rules for counting of the 05 years of experience or specificity of the nature of this experience in context of

direct recruitment. Moreover, Doon University also did not frame and/or publish any notice about the criteria/rules to be applied for counting of 05 years of experience in context of direct recruitment. The process of advertisement, screening of applications and interview of shortlisted candidates was accomplished before 30th June 2010 i.e., the date of notification of *UGC Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges and Measures for Maintenance of Standards in Higher Education, 2010*. Hence, the report submitted by three-member (Prof. I. S. Chauhan, One UGC official and Registrar of Doon University) committee is erroneous and also imaginary upto a significant extent because its findings are not based on *UGC Regulations, 2000* and the advertisement issue by the University in March 2010. On this ground, this report is not just and proper and hence, cannot be adopted to ascertain the eligibility or ineligibility of Dr. Surendra Singh Suthar.

- (ii) The report of single-member fact finding committee (submitted by Prof. R.K. Kale) highlights that Dr S.S. Suthar had clubbed together different short durations of his service and also shown different designations. Such a clubbing (whether done intentionally or unintentionally by mistake) did not bring any qualitative or quantitative change in the total length, nature or specificity of the five years of the experience which Dr. Surendra Singh Suthar was supposed to have while submitting the application for the post of associate professor in the year 2010. Hence, this report and the findings therein, are declared to be insignificant in context of his eligibility or ineligibility for the post of Associate Professor. The resolution (*"The Executive Council is of the opinion that Dr. Surendra Singh Suthar deserves dismissal from the University service. However, taking a lenient view, considering his young age, the Council unanimously resolves that his rank from Associate Professor be reduced to that of an Assistant Professor. This decision would be effective from the date it is conveyed to him."*), made by the executive council vide resolution no. 2017:26:04 in its 26th meeting on 07th June and 8th 2017, is also withdrawn because the resolution was made in the light of the aforementioned single-member fact finding committee report and/or three-member committee report.
- (iii) As the controversy or allegations of the complainants about the eligibility/ineligibility of Dr. Surendra Singh Suthar for the post of Associate Professor revolves around the five-years of his teaching and/or research experience, the Executive Council resolved to constitute a fresh three-member committee: 1- Prof. Satish Chandra Garkoti, School of Environmental Science, JNU, 2- Prof Ajeet S Negi HoD Forestry and Natural Resources HNB Garhwal University Srinagar Garhwal 3- Dr. H.M. Aazad, Dy. Registrar, H.N.B. Garhwal University, Srinagar. The mandate of this committee will be to inquire: (a) Whether Dr. Surendra Singh Suthar was having the five-years of teaching and/or research experience excluding the period spent for obtaining the Ph.D. degree and having made a mark in the area of scholarship as evidenced by quality of publications, contribution in education and innovation, design of new courses and curricula (b) If Dr. S.S. Suthar was not having such an experience or his experience was in violation of UGC Regulations, 2000 and the advertisement

issued by Doon University, the committee will assign clear and categorical reasons to substantiate and corroborate the findings.

The Executive Council also expressed displeasure on how the complaints against faculty members have been handled by the university without having its own redressal mechanism for service matters of faculty members. Executive Council also made an observation that Rajbhawan and /or State Government start taking note of such complaints when these are not disposed of at the level of the university in a proper manner. It has been observed that university must also take an affidavit from the complainant(s) regarding the correctness and factual nature of complaints. If some complaint is received and found to be factual, University must also consider the factor of delay. Delay makes the entire action unreasonable in some of the matters. Executive Council also directed the University to put a redressal mechanism in place to deal with the complaints and their disposal as per law.

Item 2021:33:12 To report of engagement of contractual faculty members

The Executive Council having considered the agenda post approved engaged/ re-engaged guest/ contractual faculties in various Schools/Departments of the university for the academic session 2020-21 and 2021- 22

Item 2021:33:13 To report relieving of Dr. Rajesh Kumar, Associate Professor School of Media and Communication Studies for joining as Professor in Indian Institute of Mass Communication (IIMC), New Delhi consequent upon his selection.

The Executive Council took note the relieving of Dr. Rajesh Kumar to join the post of Professor with retaining lien on his post of Associate Professor at Doon University for a period of two years or till his confirmation on the new post at IIMC, whichever is earlier.

Item 2021:33:14 To consider and approve Ph. D. study leave to three faculty members namely Ms. Deepika Bhatia, Assistant Professor, Ms. Juhi Prasad, Assistant Professor and Mr. Ravi Kumar, Assistant Professor

The Executive Council approved the study leave. In the discussion the Additional Secretary, Uttarakhand Government informed that state government did not adopt rule for study leave with full salary. The rule existing so far is study leave with half pay. Doon University stated that university is granting DL with full pay as per the provisions laid down by the University Grants Commission (UGC). However, EC resolved that directions from government will be obtained in matter regarding salary during study leave keeping in mind the provisions of Act and Statutes of the University.

Item 2021:33:15 To report the matter of extension of engagement period of Dr. Savita Karnatak Tiwari as a Visiting Assistant Professor at Doon University.

The Executive Council approved to engage Dr. Savita Karnatak Tiwari, visiting Assistant Professor, Psychology for one year w.e.f. 15th February 2021 on the same terms and conditions as was in his previous engagement.

Item 2021:33:16**To consider engagement of Visiting Professors in Geology, Geography, Anthropology and Biological Sciences.**

The Executive Council considered the proposal and approved to engage following academicians as Visiting Professors for two years or up to 65 years of age whichever is earlier on such terms and conditions as decided by the university on the basis of statutory provisions:

The Executive Council having discussed the proposal approved to engage Dr. Harsh Pati Dobhal as Visiting Professor for two years w.e.f. January 27, 2021 on the same terms and conditions as was in his previous engagement.

Item 2021:33:18**To consider and approve making of matter of Golden Card under Ayushman Bharat scheme.**

The Executive Council approved the proposal regarding making of Golden Card of University officers/ teachers/ staff under the Ayushman Bharat/Atal Ayushman Uttarakhand scheme to cover them under the State Government Health Scheme.

Item 2021:33:19**To consider and approve Proposal for teaching and staff positions for Centre for Uttarakhand Languages, Folk Performing Arts and Culture and (Uttarakhand Bhasha, Lok Kala Evam Sanskriti Nishpadan Kendra).**

The Executive Council having discussed the proposal approved establishing the centre and the proposal of creation of faculty and staff positions for the following academic programs under the centre.

Item 2021:33:20 **To consider and approve establishment of School of Biological Sciences and proposal of creation of teaching and non-teaching positions for the school.**

The Executive Council approved the establishment of School of Biological Sciences and introduce Integrated M.Sc. Biological Science and proposal for faculty and staff positions.

Item 2021:33:21 **To consider and approve establishment of Dept. of Home Science, to start M.A. Home Science under it a proposal of creation of teaching and non-teaching positions for the Department.**

The Executive Council approved the establishment of Department of Home Science, introduce M.Sc. Home Science and proposal for faculty and staff positions.

Item 2021:33:22 **To consider and approve the following resolutions of the Academic Council made in its 29th meeting held on 23rd April 2021.**

The Executive Council approved the following resolutions of the Academic Council made in its 29th meeting on 23rd April 2021:

1. Recommendations of the committee regarding minor modifications in the rules and regulations of the examination system of Doon University in the interest of students.
2. Establishment of Research and Innovation Cell in the University and the guidelines about its mandate and functioning in the entirety.

The Executive Council took note of establishment of an Office for International Affairs to facilitate the international students seeking for admission in Doon University and approved the guidelines for Admission of Foreign Nationals in the University.

The Executive Council approved the proposal to authorize the Vice Chancellor for recruitments in lower teaching positions against sanctioned positions of higher posts in different departments and schools of the University as and when required.

Item 2021:33:25 **To consider modification in the qualification of Senior System Analyst.**

The Executive Council approved the qualification and experience as following:

M.Tech (C.S./Electronic/IT) with at least 5 Years of experience
or
B.Tech (C.S./Electronic/IT) with at least 7 Years of experience
or
M.C.A. with at least 5 years' experience.
or
M.Sc. (IT/CS) with at least 7 years of experience
The Executive Council may like to consider and approve the same.

Item 2021:33:26 To report the provisions made by the University to help such poor and destitute children who have lost their earning parents due to covid-19 and other serious illness during the covid period.

The Executive Council took a note.

Item 2021:33:27 To consider the matter of allotting the University Cafeteria to a Women Self Help group for the time being.

The EC appreciated this initiative and approved the proposal to run the cafeteria by Manan Vaibhav Self Help Group for one year on trial basis. If their services are found satisfactory, they may be allowed to work for ahead with the terms and condition stipulated by the University.

Item 2021:33:28 To apprise the Executive Council about the recruitment process of non-teaching positions in the University.

The Executive Council took a note about the recruitment process of non-teaching positions in the University.

Item 2021:33:29 To consider and approve to engage Adjunct Professor and Adjunct Faculty in the Dept. of Chemistry.

Having gone through the agenda and profiles, the executive council approved the honorary engagement/affiliation of (i) Dr. Padmanabhan Balaram (Padma Bhushan), former Director, Indian Institute of Science, Bangalore as Adjunct Professor, and (ii) Dr. Shailesh Upreti, President, Charge CCCV New York, USA as Adjunct Faculty on such terms and conditions as decided by the university on the basis of statutory provisions, if any, for the guidance and quality improvement in the academic matters of the Department of Chemistry, School of Physical Sciences.

Item 2021:33:30 To consider the replies of the three faculty members in response of the resolutions of the Executive Council on the report of inquiry committee constituted by the Government of Uttarakhand in the matter of objections raised in Doon University audit examination for the year 2014-16 by the Uttarakhand Audit Department.

The EC went through the replies/ comments of all three faculty members w.r.t. the report of the inquiry committee constituted by Govt of Uttarakhand in this regard. The EC also heard all three faculty members, one by one, in person.

After due deliberations, the EC resolved to constitute a fresh three members committee. The three members will be:

- (i) Dr. Vikas Gupta, Registrar, University of Delhi (Chairman)
- (ii) Prof. H.C. Purohit, Director IQAC (Member)
- (iii) Dr. H.M. Aazad, Dy. Registrar, H.N.B. Garhwal University, Srinagar

The mandate of this committee will be:

- (i) To examine the internal departmental audit committee report (comprising the then officiating VC, the then Registrar and the FC), audit report received from Principal Secretary (Finance) Govt of Uttarakhand, inquiry committee report from Joint Secretary Higher Education Govt of Uttarakhand over this audit report, replies of all three faculty members and all other relevant facts and documents on record.
- (ii) To ascertain the date of eligibility of Dr. Archana Sharma and Dr. Vijay Sridhar for promotion from AGP 6000 to AGP 7000 and assign the reasons to substantiate and corroborate the recommendation about such a date.
- (iii) To provide clear view (a) If Prof. Kusum Arunachalam could be promoted directly from AGP 6000 to the AGP 9000 under career advancement scheme (b) To ascertain the date(s) of her eligibility for promotion from AGP 6000 to AGP 7000, AGP 7000 to AGP 8000 and AGP 8000 to AGP 9000 on the basis of counting of her past services in the case of the view of the fresh committee that she could not be promoted directly from AGP 6000 to AGP 9000

After considering the verbal submission of Prof. Kusum Arunachalam about the non-payment of arrears under 7th Pay Commission for the post of Professor, executive council resolved that Prof. Kusum Arunachalam may be given 7th Pay Commission arrears for the post of Professor after withholding the amount as per actual calculations in the light of audit objections and inquiry committee report in this regard.

The EC opined that it was the discretion of the Vice Chancellor to take a decision with regard to making it mandatory to process all financial matter related files through the Registrar. The EC resolved that the Vice Chancellor may take a decision in this matter in the light of university Act and practices in other university in the state.

Item 2021:33:33:02 To consider the representation of employees of Doon University through UPNL regarding the Recruitment process to non-teaching posts in the University.
