Item 2023:36:08 To consider the matter of additional increment given to Dr. Mala Shikha, Ms. Tanvi Negi and Mr. M.K. Jha, Assistant Professors at the time of appointment.

Having discussed the matter, the Executive Council was of the view that the additional increment was given to three faculty members by the respective Selection Committee. Probably the increment would have been given on the basis of past experience of the respective faculty members. Therefore, the Executive Council cannot take cognizance of the complaint filed on the matter after a period of more than one decade.

Item 2023:36:09 To consider and approve enhancing number of seats for admissions in M.A. Psychology Program, M.A. Theatre Programme, B.A. Geography and B.A. Geology.

The Executive Council considered the agenda and approved enhancing number of seats for admissions in M.A. Psychology Programme, M.A. Theatre Program, B.A. Geography and B.A. Geology as per following details:

The E.C. also approved admissions of those candidates who have been granted admission over and above the previous intake in anticipation of enhancing the seats.

Item 2023:36:10 To consider giving post facto approval on appointment of Prof. Harsh Dobhal, as Visiting Professor in SoMCS.

The Executive Council granted approval on the extension given to Dr. Harsh Dobhal as Visiting Professor in the School of Media and Communication Studies upto June 2023.

Item 2023:36:11 To consider the request of M/s Chef Hospitality regarding the name of firm from Black list.

Having considered the agenda, the Executive Council resolved to remove the name of the firm M/s Chef Hospitality from blacklist. While removing the name of the firm from the blacklist, the Executive Council also observed that the firm concerned had duly clarified the reason for their mistake and regretted its action; and the firm has been adequately penalized by virtue of its blacklisting for two years.

Item 2023:36:12 To consider and approve request of Ms Tanvi Negi, Assistant Professor, Dept. of Chinese regarding leave.

Having considered the agenda, the Executive Council approved the request of Ms. Tanvi Negi, Assistant Professor, Dept. of Chinese regarding granting extension to her study leave till July 2025 on without pay to avail the ICS-HYI Fellowship 2023.

Item 2023:36:13 To apprise the Executive Council about the Office order no. 140379/XXIV-C-2/2023/10(04)2023 dated 24 July 2023 of Dept. of Higher Education.

The Executive Council discussed the agenda and resolved that the committee be constituted to examine the matter in view of the G.O. allowing the general public in the university sports ground and university concerns over the safety of families of faculty and officers and Girls Students residing in the hostels of the University.

Item 2023:36:14 Apprising the Executive Council of the university about the order dated 01/09/2023 passed by the Hon'ble High Court of Uttarakhand in Writ Petition(S/B) 402 of 2023 — Dr. Kusum Arunachalam and others vs Doon University & others.

The Executive Council took note on the order dated-01/09/2023 of Hon'ble High Court of Uttarakhand dismissing the Writ Petition (S/B) no. 402 of 2023 challenging eligibility and appointment of Dr. S.S. Suthar as Associate Professor at School of Environment & Natural Resources, Doon University.

Item 2023:36:15 Hon'ble High Court of Uttarakhand order dated- 29/08/2023 in WPPIL 123 of 2022 — Anu Pant vs State of Uttarakhand & others.

The Executive Council took note of Hon'ble High Court of Uttarakhand order dated 29/08/2023 in WPPIL 123 of 2022 — Anu Pant Vs State of Uttarakhand & others wherein the Hon'ble Court had directed the Doon University to proceed to act on the special audit report communicated by the Uttarakhand Government dated 13/11/2017. The Executive Council noted the fact that the Hon'ble Court had directed the university to act on the report without waiting for any further orders by the court in this petition. The Hon'ble Court has also directed the university to file Action Taken Report to the Hon'ble Court on all aspects covered in the special audit report before next date, i.e., 03rd April 2024.

The Executive Council was apprised about different events and actions taken by the University and the Government. in a chronological way w.r.t. findings of special audit report as — receipt of special audit report dated 13/11/2017, statements and clarifications given by the affected persons, namely Prof. Kusum Arunachalam, Dr. Vijay Shridhar and Dr. Archana Sharma, departmental audit committee report dated-21/12/2017, formation of an inquiry committee by the Government, resolutions of previous Executive Council meetings in this matter and formation of a fresh inquiry committee by the University. The EC took note of all these developments and related documents.

Having discussed the whole gamut of issues and related developments, the Executive Council noted the fact that the University acting upon the directives in the letter no. 300/xxvii(62)/2017 Dated 13/11/2017 sent by Uttarakhand Government w.r.t. findings of special audit report (2014–16) had constituted a departmental audit committee as per stipulated procedure. The report of this departmental audit committee was duly prepared and sent to Higher Education Dept. of Uttarakhand Government vide letter no. 121/vibhagiya lekha pariksha/2016–17 dated 21/12/2017. This departmental audit committee has clearly enunciated the desirable course of action in relation to all points

raised in the special audit report sent by the Government vide letter no. 300/xxvii(62)/2017 dated 13/11/2017.

Rather than acting upon the report of the departmental audit committee report dated 21/12/2017, reading this report with all 07 (seven) points in relation to special audit findings mentioned in letter no. 300/xxvii(62)/2017 Dated 13/11/2017 sent by the Uttarakhand Government, the University and the govt took a completely different path of action and formed different inquiry committees to look over the matter, which was not warranted and against stipulated rules for resolution of audit objections. The Executive Council also noted the fact that the reports of Government formed inquiry committee and the report of university formed inquiry committee over the same matter are completely different. In view of these facts, the EC resolved not to take these inquiry committee reports into consideration while taking action over the special audit report sent by the Uttarakhand Govt vide letter no. 300/xxvii(62)/2017 Dated- 13/11/2017.

After extensive deliberations on all aspects covered in the special audit report, the Executive Council resolved and directed the university to act in accordance with the report of the departmental audit committee dated- 21/12/2017 in relation to letter no. 300/xxvii(62)/2017 dated- 13/11/2017 sent by Uttarakhand Govt w.r.t. findings of special audit report (2014-16). Accordingly, Action Taken Report should be submitted to the hon'ble high court before 3rd April, 2024.

Item 2023:36:16 To apprise the Executive Council about the relieving of Dr. Ravi Kumar, Assistant Professor to Join JNU, New Delhi.

The Executive Council was apprised about the relieving of Ravi Kumar to join JNU as Assistant Professor, New Delhi. The Executive Council approved the same.

Item 2023:37:17 Construction of temporary cottage-like structures around inside boundary of the university for staff members performing emergency/essential services duties.

Having considered the agenda, the Executive Council resolved that the university may construct a purely temporary and fabricated dwelling structures comprising one bedroom, one kitchen and one toilet-cum-bathroom for its emergency/essential duty staff.

The Executive Council also resolved that the university may spend an amount to the maximum of Rs 40 Lakhs for creating such a facility. The staff members using this facility shall be paying electricity and water consumption charges.

Item 2023:36:18 To consider and approve revision in fee structure of UG and PG courses in Geology and Geography.

The Executive Council resolved that the proposal of revision of fee structure of UG and PG courses in Geology and Geography be put in the next Finance Committee meeting. After consideration of the Finance Committee the proposal may be put in the Executive Council.

- Item 2023:36:19 To consider and approve recruitments of 2 Assistant Professors on contract for B.Tech. Computer Science and Engineering (CSE) on the consolidated remuneration of Rs. 65,000/- per month to each.**

The Executive Council discussed the agenda and approved recruitments of 2 Assistant Professors on contract for B.Tech. Computer Science and Engineering (CSE) on the consolidated remuneration of Rs. 65,000/- per month to each for effective implementation of NEP-2020, to teach various advanced skill enhancement courses of B.Tech. Computer Science and Engineering along with the various core technical courses and practical labs. the expenditure made on salary of these two contractual faculty members shall be borne out of the corpus of funds created from fee paid by the admitted students in self-financed B.Tech. (CSE) course.

- Item 2023:36:20 To consider the proposal of establishing an Advance Computer Lab for B.Tech. Computer Science and Engineering.**

The Executive Council having considered the agenda approved the proposal of establishment of one Advance Computer Science Lab for newly started B.Tech. Computer Science and Engineering programme which will also assist in facilitating the various skill-based training/workshop/seminars and teaching facilities. The estimated budget for the Lab infrastructure is Rs. 48,76,000/- which includes furniture, desktop PC, Printer, Projector, AC and networking was also approved by the Executive Council.

- Item 2023:36:21 To consider the proposal of establishing Computer Lab for the Dept. of Mathematics Lab.**

The Executive Council considered the agenda item and granted approval with the direction that the University should first completely create the necessary infrastructures for the computer lab of Dept. of Mathematics. After that necessary software should be procured. The E.C. also approved the estimated budget of Rs. 97,52,851 (for the software is Rs. 60,58,260/- and for infrastructure Rs.36,94,591/-). The expenditure on establishing the computer lab will be borne by the University from its own resources.

- Item 2023:36:22 To consider the matter of fixing maximum limit of late payment taken from the students who deposit the fee after due date.**

Having considered the agenda, the Executive Council resolved that the present system of late payment charges being levied by the university should be done away with; and instead, the university should levy a late payment @ 10% interest on semester fee of respective academic programmes w.e.f academic session 2022-23.

If a student fails to deposit his/ her semester fee before the end-semester exam of a particular semester, he/ she should not be allowed to sit in the end-sem exam and his/ her name should be struck off the class rolls. It will be the responsibility of the School/ Dept Heads/ ICs to ensure that the students deposit fee on time and in the event of late payment, before end-semester examination with late fee @ 10% interest on semester fee, failing which the School/Dept must struck his/her name off the class rolls and he/

she should not be allowed to sit in the class. Similarly, it shall be responsibility of the Boys and Girls Hostel Wardens to ensure payment of hostel fee on time every semester and with late fee @ 10 % interest on hostel fee before the end of every semester, failing which he/ she should be asked to vacate his/ her allotted hostel room.

Item 2023:36:23 To consider and approve remunerations for over time duty done by Caretakers and Electricians engaged through UPNL.

The Executive Council considered the agenda, approved remuneration to the Electrician and caretakers for extra duty done by them in place of the person who goes on leave.
