To modify the fee structure of the University from the academic session 2014-15.

At present the University charges fee from students in two broad heads: Tuition fees and Other Fees at the time of admission. The other fees comprises of various sub heads, such as equipment consumable fee, library fee, computer/internet fee, examination fee, sports/game/cultural/activity fee, miscellaneous fee, medical fee, professional exposure, student aid fee. Details of fees as charged, is attached as Annexure. The University is not charging any fee for magazine and issuance of degree. The Standing Committee on Admission and Evaluation, having considered the matter in its meeting held on 7<sup>th</sup> March 2014 has proposed to change the fee structure of the University from the academic session 2014-15 as follows.

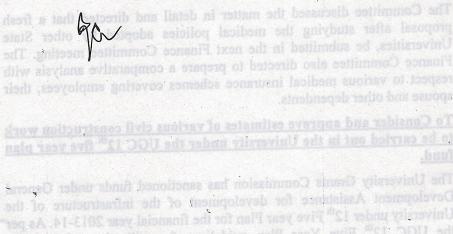
The Finance Committee approved the proposals recommended by the building committee.
