Minutes of 19th Meeting of the Finance Committee

19TH meeting of Finance Committee was held on today 26th August, 2020 under the chairmanship of Dr. A. K. Karnatak, Vice Chancellor, Doon University at his office. Following members were present in the meeting.

Item 2020:19:01 Welcome of the Finance Committee members by the Vice Chancellor.

Item 2020:19:02 Confirmation of the minutes of the Proceeding of the 18th Finance Committee meeting held on 16th April'2019 at Doon University, Dehradun.

Finance Committee confirmed the minutes of its 18th meeting as no observation/suggestions were received from any member of Committee.

Item 2020:19:03 Review of action taken on the resolutions of 18th Meeting of the Finance Committee.

Finance Committee reviewed action taken on the resolution of 18th meeting of the Finance Committee

Item 2020:19:04 To approve estimated budget for F.Y. 2020-21.

The Finance Committee considered the budget estimate with the change that estimated budget for salary head be kept as per provision of State Government which is ₹ 12 Crore 65 Lac, with this change the committee approved the total budget of ₹35 Crore 36 Lac for F.Y. 2020-21. (Annexure attached)

Item 2020:19:05

To approve the honorarium to Executive/Selection Committee members / faculties/Guest faculties for various jobs assigned to them.

After taking cognizance of the honorarium rates of the various Universities the Finance Committee recommended the following honorarium rates on the ground that the University is created on the pattern of JNU to maintain the academic standards. The committee resolved that the rates may be approved by Executive Council.

- Executive Council/Academic Council/Finance Committee (External members only) @ ₹ 4000 per day

- Selection/Screening Committee members @ ₹ 3500 per day (External members only)

- PG evaluation of project/dissertation report – (Minimum ₹ 1500 Maximum ₹ 2500) (External members only)

- Ph.D/ Thesis evaluation - ₹ 2000 (External members only)

- Ph.D Viva-Voce - ₹ 2000 (External members only)

Item 2020:19:06

To approve the payment of balance of construction cost of Rs. 12 Crore 39 Lakh 33 Thousand for the construction of Dr. Nityanand Himalayan Research and Study Centre from the general fund of the University.

The Finance Committee considered the funding pattern of the said project. The Committee observed that the University has already been allotted a sum of ₹826.22 Lac towards this project. The remaining amount is to be utilized in the F.Y. 2020-21. The provision under capital expenditure by the State Government is ₹5.00 Crore only in which ₹109.35 lac are to be released this year for another ongoing project.

The committee resolved that the ₹ 3 Crore 90 Lac for the Research and Study Centre may be obtained from the budget provision and for the balance amount, the University fund may be utilized after the approval of Executive Council and with the permission of the State Government.

Item 2020:19:07

To approve the construction work/repair of electrical panel of the University of estimated cost of ₹ 77.06 Lac from the general fund of the University.

Finance Committee considered the above proposal and noticed that a provision has been made in the budget for the F.Y. 2020-21 for maintenance. The Finance committee opined and resolved that the University may send the proposal to the Government of Uttarakhand for administrative and technical approval (TAC) after the approval of Executive Committee.

Item 2020:19:08

To consider and approve the proposal of appointment of Group D staff on outsourced basis as per the requirement of various sections and departments of the University.

e C Finance Committee discussed the matter and directed to send the proposal to Government of Uttarakhand with justification to create the additional posts of Group 'D' after the approval of Executive Council.

Item 2020:19:09

To consider and approve the proposal for advertisement of the University through various private magazines.

The Finance Committee discussed the matter and did not approve the proposal.

Item 2020:19:10

To consider and approve the proposal for signing of MoU with Hans foundations.

The Finance Committee discussed and considered the proposal and it was resolved that the proposal is to be examined in the light of University's Act and statutes. The Finance Committee also directed to form a Committee under the chairmanship of an eminent Scientist to examine the proposal. If the proposal is found suitable/appropriate then after legal vetting of the MOU further action can be taken.

Item 2020:19:11

Any other item with the permission of chair.

Item-1 Regarding the fees waiver of Student.

The Finance Committee considered the proposal for waiving of fees for students and resolved to waive all other fees (sports, Library, culture Activity, Computer/Internet, Professional Exposure, Equipment, Laboratory etc.) except tuition fees considering the Covid-19 situation till the classes are running online with the approval of Executive Council. All the above fee shall be resumed as soon as the students join the campus physically.

Item-2 Regarding the Payment of Mess bill/Mess staff salary during Lockdown period.

The Finance Committee deliberated the matter and resolved that after 1st April, 2020 the payment can not be made.

Item-3 Regarding the appointment of Legal Council (Retainer ship)

The Finance Committee resolved that Doon University has already appointed legal counsel in Uttarakhand High Court for legal court cases. At present, there is no need of extra legal counsel for Doon University and the proposal was not approved.
