The Stores and Purchase office of Doon University, Dehradun invites E- TENDERS in TWO BID SYSTEM (Technical Bid and Financial Bid) from reputed Manufacturer / Authorized Distributors / Dealers (who have the current authorization from the Principal Company) for the supply of subsurface imaging instruments (Electrical Resistivity Imaging Instrument and Ground Penetrating Radar) and Portable Automatic Weather Monitoring Station for various applications in Geosciences for the Departments of Geography and Geology as per Annexure IV.
